LOCATION OF THE CONFERENCE SESSIONS

The conference will be held at the Campus Center, University of Hawaii at Manoa, 2465 Campus Road, Honolulu, 96822. The building has disability access from the East and West entrances.

TECHNICAL PROGRAM AND SESSIONS

The technical program shall be prepared in detail once we know better after you fill this form for who is attending on-site and online. In the meantime, note that the technical sessions are planned for Oct 25-26.

You must prepare your presentations in power-point and bring them on a USB stick and be able to download them from the internet. As of now, please plan for your presentation to be 20-minutes long.

WHO CAN PRESENT?

Any author or co-author who submitted a manuscript to the workshop special issue can present either on-site or online. Mainly because some articles are still under review, you can still present if you haven't received a final decision. We expect you will make the revisions to enable the editors to eventually accept your manuscript. But that said, if your manuscript has been returned to you for improvements, please modify your manuscript as soon as possible and submit the improved manuscript.

Please note that it is a condition of the workshop that all those who have submitted manuscripts should attend and present at the workshop.

ZOOM ADDRESS for ONLINE PRESENTATIONS

The Zoom address shall be sent to all for online presentations. If you say you are attending on-site, we expect you to be physically present.

ACCOMMODATIONS

There is no designated conference hotel, so please make your own reservations. However, we recommend the following two hotels because of their relative proximity to the University of Hawaii at Manoa and Waikiki Beach, and cost economy:

- Waikiki Beach Marriot Resort and Spa, 2552 Kalakaua Ave, Honolulu, HI 96815

But please note that we have not contacted these hotels and nor have we reserved any rooms with them. This will be up to you. You will find that these hotels are right at the world-famous *Waikiki Beach*. So, you will do well if you bring your swimming trunks and costumes, sunscreen, and dark glasses with you!



MEALS AND DRINKS AT THE CAMPUS CENTER

The Campus Center has a food court, a subway sandwich shop, Starbucks, and Jamba Juice. An adjacent building has a nice Vietnamese restaurant and bar that usually serves chicken curry, as well as sandwiches! The food court has full plate lunches with choices of meat and starch; an extensive salad bar with multiple choices and make-your-own-salad-combo; an American grill where you can get hamburgers, fish sandwiches and fries, etc.; and a bento stand where you can quickly grab a ready-made box.

During the lunch break, you may visit any of these restaurants and pay your own. For the coffee/tea breaks, as well, you can get soft drinks from the food court and Jamba Juice -- and tea and coffee from Starbucks. Charge cards are accepted at all locations.
